KEYNOTE SPEAKER

Richard Monocchio

Richard Monocchio is the First Deputy Commissioner at the Department of Buildings. He joins Buildings after spending nearly a year in the same capacity at the Department of Construction and Permits.

Monocchio has a long history in the construction and housing field, having served in the administration of President Clinton at the Department of Housing and Urban Development. While at HUD, he was assigned to the Chicago Housing Authority and oversaw the demolition and new construction of public housing. Monocchio then served as chief of staff for the Chicago Airport System, with a primary focus on the construction of the new Midway International Airport.

Subsequently he served for over 6 years as First Deputy Commissioner at the Department of Housing, where he was responsible the financing and development of thousands of units of affordable housing. He was also involved in the creation of innovative housing programs such as the Troubled Buildings Initiative and Chicago Partnership for Affordable Neighborhoods.

He began his career in the federal government, serving as senior adviser to U.S. Representative George E. Sangmeister.

LIFETIME ACHIEVEMENT AWARD

James M. Flanagan

Heil, Heil, Smart & Golee, Inc. (HHS&G) was formed by James M. Flanagan in 1972 when he merged Heil & Heil, Inc. with Smart & Golee, Inc. As a young man with his Bachelor's Degree in Business from Northwestern University, Jim Flanagan began his career at McKey & Pouge. Jim wore many hats as he oversaw the diverse organization he assembled which included real estate management and development, insurance, bank ownership, appraising and auctioning property, bad-loan workouts for the Continental Bank of Chicago, golf course ownership and the always-exciting assignment of properties in receivership.

While assembling a sizeable real estate portfolio in the nineteen seventies and eighties which included property on Lake Shore Drive, Goethe, Altgeld, Wells Street, Prairie Avenue, multiple parcels in Evanston, a shopping center at Deerfield & Milwaukee in Riverwoods, Illinois and a distressed shopping center in Delafield, Wisconsin, Jim & his brother Tom purchased the majority shares of the First National Bank of Northbrook. During their ownership, they added two branch offices and purchased another bank for the holding company, the First Security Bank of Cary-Grove. In 1993, the holding company, First Northbrook Bancorp merged with Premier Financial of Freeport, IL. The subsequent mergers have led to the current ownership by Fifth Third Bank.

Since 1972, Jim Flanagan oversaw the Heil & Heil Insurance Agency, Inc. as Chairman of the Board. The Agency developed into a full-service agency, offering commercial and personal lines, life & health insurance, long-term care, and even aviation insurance via a subsidiary, Dickens & Co. Until sold in the early 1990's, there were aviation insurance offices in Minnesota, Texas and Oklahoma as well as Illinois. H&HIA grew from an office with three employees to personnel of over fifty, seven of whom occupy the Naperville office.

Mr. Flanagan was well known for high character and business acumen. His impact on the real estate industry is far reaching. His property management company has helped elevate standards in the community management market. Al Schroeder and Tim Snowden of Heil Heil Smart and Golee have served as mcd media advisory board members for nearly 10 years. Both have served on event committees, authored articles, encouraged subscriptions, and been active in several industry trade groups. Current president Bob Landers and their entire management team support education and professionalism throughout the company.
